**ELIGIBILITY CRITERIA FOR STREAM ALLOCATION IN CLASS XI**

Dear Parents,

The school has made you aware of the assessment pattern to be followed throughout the session during the Orientation conducted on Saturday, 3 April 2021. The assessment pattern strictly adheres to the guidelines laid down by the CBSE. During the session, students' learning will be evaluated using different forms of assessments. Performance of your ward in these assessments will be indicative of her/his aptitude and grasp on the different subjects.

We would like to bring to your notice that the allocation of Stream and subjects in Class XI will be based upon your ward's academic performance.

- If the session continues to be conducted in the online mode, your ward's performance in Class IX Final examinations, which were conducted in the **offline mode**, will be considered for allocation of the Stream and subject choice for class XI.
- If the Government allows schools to reopen physically and the examinations (Mid Term, Revision and Pre-Board Examination) are conducted **offline**, then the allocation will be based on the performance in these exams.
- In case all the Examinations in Class X are conducted in the **online mode**, the school will conduct an Eligibility Test in Science and Math for Stream allocation.

Therefore, it is imperative that your ward invests requisite efforts in her/his academics throughout the year, to qualify for the Stream/subjects of her/his choice.

**The school offers the following subject options in the three Streams:-**

***\* In the Science stream, if a student opts for Computer Science as the fourth subject, she /he has to compulsorily select Mathematics as the fifth subject.***

Please Note:

- English Core is compulsory for all Streams.
- As per CBSE rule, a student cannot study Mathematics as a subject in Class XI without having qualified Mathematics Standard in Class X.
- Due to limited seats, Economics/ Psychology/ Home Science will be offered on a first come first served basis at the time of registration.
- Students will be permitted to change their Stream/subjects on declaration of class X CBSE results, provided they meet the eligibility criteria for the Stream/subjects they opt for. However, they will be responsible to cover the syllabus on their own.
- If a student opts for a sixth subject, it will be her/his sole responsibility of studying the subject on her/his own.
