## ADMISSION TO PRE-SCHOOL (NURSERY)

### SESSION 2026-27

- Children born between 1 March 2022 and 30 April 2023 are eligible for admission to Pre-School (Nursery).
- In accordance with the guidelines of the NEP 2020, children admitted to Nursery in the academic year 2026-27 will be required to complete three years of Pre-Primary education before being promoted to Class I.

The age criteria for admission Nursery (2026-27) and subsequent progression are as follows:

Year	2026-27	2027-28	2028-29	2029-30
Class	Nursery	Lower KG	Upper KG	Class I
Age	3+ years	4+ years	5+ years	6+ years
	as on 31 March 2026	as on 31 March 2027	as on 31 March 2028	as on 31 March 2029

Admission to Nursery will be granted only to children who are 3+ years of age as on 30<sup>th</sup> April 2026. These students will progress to the next level as stated above, and will move to Lower KG in the session 2027-28.

### GUIDELINES FOR FILLING ONLINE REGISTRATION FORM

- It is **mandatory to submit** the printed copy of the Online filled form, along with the required documents, in the school office, failing which the registration shall stand cancelled.

#### A. Steps for filling Registration form:

- 1) It is compulsory to fill all columns marked with asterisk (\*).
  - 2) Fill the Form in **CAPITAL LETTERS**.
  - 3) **An incomplete registration form will be automatically rejected.**
  - 4) After completing the registration form, click on SUBMIT to upload the form. You will get an auto generated acknowledgement receipt with user ID and password on it. These are to be used for future reference. Pay the **Registration fee of ₹ 25/-**.
  - 5) Print the filled copy of the form along with the acknowledgement receipt.
  - 6) Attach photocopies of the required documents (self-attested, mentioned below) and the Acknowledgement Receipt with the printed copy of the form and **submit it to the school office by Saturday, 27 December 2025 till 12 noon.**
- **Forms can be submitted on all working days.**

➤ **List of Documents to be attached:**

1. Date of Birth Certificate of the Child (Affidavit will not be accepted)
2. **Proof of residence (any TWO different types of proof of same address):**
  - a) Aadhaar Card
  - b) Passport in the name of any of the parent /child
  - c) Driving License
  - d) Registered Rent agreement
  - e) Voter Id-Card
  - f) Water, Electricity, Gas or Telephone Bills (not older than 3 months in the name of either parent)
  - g) Ration Card/ Smart Card (issued in the name of Parents bearing the name of the child)

**Please Note:**

- **Address proof of the same type (i.e. Passport/ Aadhaar Card) of both the parents will be considered as one Proof only.**
  - **Bank documents will not be accepted.**
  - **If only one proof of residence is submitted, the form will be disqualified.**
  - **If the same type of residence proof is given, then application will be considered invalid, for e.g. Passports of parent and child will not be accepted. The second proof should be of a different type from the first one.**
  - **The residence proofs should be in the name of mother or father of the candidate applied for ONLY.**
3. Affix one recent passport size photograph of the child and one of each parent on the form.
  4. Proof of alumnus status, any ONE of the following (if applicable).
    - a) Class XII Marksheet
    - b) Class XII Passing Certificate
  5. **Medical certificate and records of the child** (only for children with special needs).

You are requested to declare correct medical status vis-à-vis special needs, in the application form. This has to be accompanied by a complete medical report from a **CBSE approved Doctor/ Institute**. Failure to declare correct medical status will automatically disqualify the child **EVEN IF ADMISSION HAS BEEN GRANTED**.
  6. In case of **Guardian** please enclose the following documents:
    - a) Authorization letter by the parent(s)
    - b) Recent photograph of the Guardian (attested by the parents).
    - c) Proof of residence of the Guardian (as mentioned in point no. 2 above)

**NOTE:**

- i. **Insufficient or invalid documents will lead to disqualification.**
- ii. **It is mandatory to submit the printed copy of the online filled form, along with the required documents, in the school office for further processing.**
- iii. **Verification of documents attached, will NOT be done, at the time of submission of the registration form in the school office.**
- iv. **Registration is NO Guarantee of Admission.**
